

**WESTERN SUBURBS LEAGUE CLUB (CAMPBELLTOWN) LTD.
AMATEUR SPORTS GRANTS – SPORTS REPRESENTATIVES**

POLICY DOCUMENT

Objective

- To provide clear and effective guidelines that enable assessment of applications submitted to Western Suburbs League Club (Campbelltown) for the provision of financial assistance to amateur athletes who have gained selection in their respective sport at a State, National or International level.

Assessment Criteria

- The Board of Directors of Western Suburbs League Club (Campbelltown) will give consideration to applications for financial assistance to amateur athletes where the athlete meets the following criteria :
 1. The amateur status of the athlete has been confirmed **and**;
 2. The athlete has been selected in an appropriate and recognised sporting team/squad at a State, National or International level **and**;
 3. The athlete currently resides within the geographic boundaries of the Campbelltown Local Government Area (LGA) and has resided within these boundaries for a minimum period of 12 consecutive months **and**;
 4. The athlete, if over the age of 19 years, must be a member of Wests Campbelltown for a minimum period of 12 months, OR if under the age of 19 years, then the athlete's parent(s) or an immediate family member must be a member of Wests Campbelltown for a minimum 12 month period; **and**
 5. The following supporting documentation must be attached to the written application for ASG funding:
 - Written confirmation of the athlete's selection at the relevant level of representation by the athlete's local affiliated sporting club.
 - Written confirmation of the athlete's selection at the relevant level of representation by the appropriate State or National sporting organisation or School association.
 6. Written applications for approval of grants, together with supporting documentation must be submitted to Wests Campbelltown, prior to the event occurring. The ASG application will be reviewed for compliance, by the Sports Secretary, and then referred to the General Manager for final determination.
 7. Applications for any retrospective ASG funding for any sporting competitions, will not be accepted.

Notes

- All applications shall be treated upon merit having regard for the location and the duration of the event in which the athlete has been selected.
- Should the duration of the event exceed 3 days a daily expense allowance of \$20.00 may be made available for a maximum period of 14 days.
- The maximum total payment of amateur athlete grants and daily expense allowance to an individual athlete will be \$1,000 in any financial year (ie: November to October).
- All international athletes shall supply Wests League Campbelltown with proof of participation.



AMATEUR SPORTS GRANT SCHEDULE

Grant Funding

- The level of grant funds provided by Wests Campbelltown to individual athlete applications meeting **all criteria** will be in accordance with the Club's schedule of grant funds to Amateur Athletes – such schedule being determined from time to time by the Board of Directors. The current schedule is as follows :

International Competition

International competition events conducted outside Australia	\$650.00
Daily allowance – applicable where event exceeds 3 days	\$ 20.00 per day

National or State Titles (held in NSW or ACT)

Competition events held in Sydney	\$100.00
Competition events held in regional centres	\$125.00
Daily allowance – applicable where event exceeds 3 days	\$ 20.00 per day

National Titles (held in QLD)

Competition events held in Brisbane	\$150.00
Competition events held in regional centres	\$175.00
Daily allowance – applicable where event exceeds 3 days	\$ 20.00 per day

National Titles (Held in Victoria)

Competition events held in Melbourne	\$150.00
Competition events held in regional centres	\$175.00
Daily allowance – applicable where event exceeds 3 days	\$ 20.00 per day

National Titles (held in SA)

Competition events held in Adelaide	\$200.00
Daily allowance – applicable where event exceeds 3 days	\$ 20.00 per day

National Titles (held in WA)

Competition events held in Perth	\$250.00
Daily allowance – applicable where event exceeds 3 days	\$ 20.00 per day

National Titles (held in NT)

Competition events held in Darwin	\$250.00
Daily allowance – applicable where event exceeds 3 days	\$ 20.00 per day
